## Become a Pacesetter!

If you sign up for payroll deduction and elect to donate a minimum 0.8% (for BU) or 0.9% (for MAST) of your base pay, you are eligible for one paid day off as a Pacesetter.

All Pacesetters receive a paid day off in the YEAR FOLLOWING when they contribute (e.g., 2022 contributions will earn a day off in 2023).
