NATIONAL GRID FOUNDATION GRANTS \$350,000 TO WINTER FUEL RELIEF FUND

United Way of Long Island's Project Warmth received a \$350,000 grant from the National Grid Foundation that kept more than 500 Long Island families warm last winter. This is the largest contribution a United Way program has received since it began in 1964.

The recent ALICE (Asset-Limited Income Constrained Employed) Reports saw an increase in Long Island families having difficulties making ends meet, even when working two, or three jobs. With home heating costs rapidly increasing, Project Warmth is a lifeline to neighbors who are experiencing economic challenges.

"This year, more than ever, as energy prices and inflation are putting such a strain on our customers and communities, National Grid Foundation is pleased to again be able to help our neighbors by continuing our annual support of United Way's Project Warmth," said Ed White, Executive Director of the National Grid Foundation and Vice President, Social Impact for National Grid. "We are especially thrilled the funding this season will offer even more relief for fuel-neutral energy costs during this unprecedented situation. We have a long history of serving as a community partner, understand the critical need in our communities. We are grateful to organizations like United Way as they help deliver so many much-needed services during this trying economic time."

Project Warmth has helped to fill the need for emergency heating assistance on Long Island since 1994, raising more than \$13 million to help more than 31,000 families. We are one of the country's oldest non-government fuel funds, serving as a model across the United States. We are the primary source of emergency assistance (oil, gas, fuel related electric) for households who are struggling financially and have exhausted other options.

Project Warmth helped 1,143 families in the 2022-2023 winter season

Including: 803 children, 572 seniors, 106 veterans and 1,455 adults. Average Grant was \$521 per family

Families that Project Warmth served this past winter:


- 81% required emergency assistance because of a medical emergency, illness or disability.
- 19% needed help because of a loss of job or loss of loved one.
- 92% of recipients had at least one vulnerable person. Elders, young children and individuals with disabilities are most susceptible to extreme temperatures and thus prioritized by Project Warmth.
- 100% of recipients required assistance due to a disruption in family income while some are seniors on fixed incomes.
- Project Warmth's partner agencies assist recipients with long-term solutions to financial crisis, including connecting the family to other community resources, such as budget/ debt counseling, supplemental food programs or job training services.



As a single parent family, the Fatzie's had some major car repairs, and Project Warmth was able to provide some relief allowing the client to repair her car and to continue working to provide for her 3 children.



The Lorio Family was helped this past winter as the family debt was mounting. They were also referred to the EDCAP, United Way's Student Debt Assistance Program.



Long Island is a region of extraordinary high energy costs and Project Warmth is often the only resource available to those facing home heat insecurity.

Project Warmth works with 18 local agencies and more than 90 parish outreach centers that provide intake and case management services. The case management process ensures that needed services are provided to the client to resolve existing problems and reduce the need for future assistance. The process is so successful that 80% of previous year's clients did not request further assistance.
