In signing this release, I indicate my understanding of the risks involved with activities involving human powered water craft and agree to take full responsibility for my physical condition, actions and safety.

NOW THEREFORE INTENDING TO BE LEGALLY BOUND, I DO WAIVE FOR myself, my heirs and assigns and for anyone else whomsoever Claiming through me, my right to sue or in any other way to attempt to hold responsible the United Way of Long Island or the EETA its officers any so-called "race organizers" or "coordinators" or any of my fellow paddlers, for any mishaps to my person or my equipment, other than that which is due to the willful and malicious action of the individual against whom I claim relief.
