

You can help Long Islanders through Workplace Giving



The United Way drive is underway now! Enroll today, and donate to your favorite charity.

Our contributions to the United Way Workplace giving campaign in the past seven years alone have raised more than \$1 million — \$1,057,378 to be exact. And this was entirely from employee donations. Your generosity supported more than 100 local charities through the United Way of Long Island. Some of the programs our donations support include [Project Warmth Emergency Fuel Fund](#), and the United Way's [VetsBuild](#), [YouthBuild](#), and [BeReadyLI Children's Workshop](#). In addition, there are two foundations that memorialize our former co-workers — the [Charles Thide Foundation](#) and the [Paul Snyder Memorial Foundation](#).

While the actual campaign is winding down, there is no deadline to enroll – employees can opt in or out of payroll deduction or change designations at any time throughout the year. **However, to be eligible for United Way “Pacesetter” status for 2022, which includes a paid day off in 2023, there are considerations to note:**

- Bargaining unit (BU) employees must pledge 0.8% of their base salary. MAST employees must pledge 0.9% of their base salary.
- To enroll as a Pacesetter for 2022 and be eligible for a paid day off in 2023, you must have contributed the entire 0.8% of your base salary (for BU employees) or 0.9% of your base salary (for MAST employees) **by the last pay period of 2022, which is Dec. 24, 2022 for BU and Dec. 11, 2022 for MAST.**
- Below are the calculations you can perform to determine your donation for Pacesetter.
 - If you are a **represented employee**, use this formula:

Your hourly rate of pay x 2080 x 0.008) / 52

OR

Your annualized salary x 0.008) / 52

- If you are a **MAST employee**, use this formula:

Your annualized salary x 0.009) / 26

If you are currently contributing using payroll deduction, please be aware that you may sign up through the Power of Giving website (CyberGrants) for the same deduction amount, and the

company will match your contribution! If you'd like to sign up via CyberGrants, please follow the steps below. **(Note: Be sure to contact the Employee Services group hotline at 855-857-5622, option 2 then 5 for Payroll or PSEGLI-EmployeeServices@pseg.com so that they can stop your current payroll deduction and avoid a double deduction.)**

1. Log on to the PSEG CyberGrants website (you can access this from the company portal by clicking on **Power of Giving**.)

2. Click on **Let's Do Donations.**
